## **Cooling off period**

Students have rights as a consumer under Australia's Consumer Protection Laws including a 2 day cooling off period from enrolment.

## **Consumer Protection and Guarantee**

If Australian Academy of Beauty Dermal and Laser cancels or ceases to provide planned training, Australian Academy of Beauty Dermal and Laser must issue a full refund for any services not yet provided. The basis for determining "services not yet provided" is to be based on the units of competency completed by the student and which can be issued in a statement of attainment at the time the service is ceased.
